## Announcement on Issuance of Unsecured Straight Bonds

TonenGeneral Sekiyu K.K. (the "Company") notifies that it has determined the terms and conditions for the issuance of its 5th and 6th Series Unsecured Straight Bonds (with inter-bond pari passu clause) as outlined below.

1. TonenGeneral Sekiyu K.K. 5th Series Unsecured Straight Bonds (with inter-bond pari passu clause)

- (1) Total amount of issue: ¥20 billion
- (2) Denomination of each bond: ¥100 million
- (3) Application of the Act on Book-Entry Transfer of Company Bonds, Shares, etc.: The Bonds are subject to the application of provisions of the Act on Book-Entry Transfer of Company Bonds, Shares, etc. (the "Act"). Pursuant to a provision of Article 67, Paragraph 1 of the Act, bond certificates shall not be issued for the Bonds.
