Implementation of Plan for Mega Solar Power Generation in Arida, Wakayama

The Kansai Electric Power Co., Inc. ("Kansai Electric" herein) and TonenGeneral Sekiyu K.K.

implementation of the plan and aim to begin plant operations in fiscal 2014.

communities in which it operates.


